Virginia is home to many of our nation's most essential defense activities and military installations. Hundreds of thousands of military personnel and their families and veterans call Virginia home. Many large defense contractors and a multitude of suppliers and businesses support our nation's military from Virginia. With a significant portion of the state's economy linked to the country's defense activities, the Commonwealth must preserve Virginia-based military assets and support military families and veterans through increased educational and job opportunities.

#### **MILITARY & VETERANS AFFAIRS LEGISLATION**



#### UNEMPLOYMENT **COMPENSATION FOR** TRAILING MILITARY **SPOUSE**

(SB 18)



Provides that good cause for leaving employment exists if an employee voluntarily leaves a job to accompany the employee's spouse, who is on active duty in the military or naval services of the United States, to a new military-related assignment established pursuant to a permanent change of duty order from which the employee's place of employment is not reasonably accessible. The measure applies only if the state to which the spouse is transferred has a similar provision. Benefits paid to qualifying claimants shall be charged against the pool rather than against the claimant's employer.



#### **EMPLOYMENT PREFERENCE FOR VETERANS AND SPOUSES OF CERTAIN VETERANS**

(SB 516)

Provides that private employers may grant preference in hiring and promotion to a veteran or the spouse of a veteran with a service-connected permanent and total disability. The measure applies only to veterans who are honorably discharged. The measure provides that granting such preference does not violate any local or state equal employment opportunity law.

#### EDUCATION & WORKFORCE DEVELOPMENT LEGISLATION



#### STANDARDS OF LEARNING ASSESSMENTS AND REFORM (HB 930/SB 306)

Provides the number and type of Standards of Learning assessments in grades three through eight. The bill requires each local school board to certify that it has provided instruction and administered an alternative assessment, in conformance with Board guidelines, for each subject area in which the Standards of Learning assessment was not administered. The bill also requires the Secretary of Education to establish the Standards of Learning Innovation Committee to periodically review the Standards of Learning and assessments.



#### VIRTUAL VIRGINIA; SHARED ONLINE COURSES (HB 1115)

Permits the Department of Education to contract with one or more local school boards that have created online courses to make such courses available to other school divisions through Virtual Virginia. The bill requires the Department to establish the Virtual Learning Advisory Committee to advise the Department on (i) online courses, in-service training, and digital instructional resources that school divisions need to meet the Commonwealth's graduation requirements and (ii) strategic planning to expand blended and online learning opportunities in Virginia's public schools.



#### TEACHER CAREER LADDER PROGRAM (HJ1)

Requests the Department of Education to study and make recommendations regarding the feasibility of implementing a Teacher Career Ladder program in the Commonwealth.



#### WORKFORCE DEVELOPMENT (HB 1009)



Recasts the Virginia Workforce Council as the Virginia Board of Workforce Development. The Governor is authorized to appoint a Chief Workforce Development Advisor who shall serve as lead staff to the Board. The bill also directs the establishment of an executive committee of the Board and also authorizes certain other committees. The bill also establishes the Advanced Manufacturing Advisory Council to advise the Governor, General Assembly, and Board and to coordinate services, resources, and requests among agencies and institutions of higher education involved or requesting to be involved in the delivery of education and advanced manufacturing workforce training.



Virginia's business climate is important to the Commonwealth's economic competitiveness. Before making expansion or relocation decisions, businesses evaluate the competitiveness of potential states, including the tax system, the regulatory environment, the legal climate and other costs of doing business. Creating a competitive business climate and strengthening and expanding Virginia's economy is important to maintain Virginia's rank as the best state for business.

#### BUSINESS CLIMATE & ECONOMIC DEVELOPMENT LEGISLATION



#### STATE CORPORATION COMMISSION'S SECURE ONLINE SYSTEM (HB 168)

Requires the State Corporation Commission limit the submission of data and documents on behalf of a business entity through its eFile electronic registration system to any user (i) designated to make such submission on behalf of the business entity and (ii) whose identity has been established satisfactorily through a verification process.



#### UNAUTHORIZED FILINGS WITH THE STATE CORPORATION COMMISSION (HB 313)

Authorizes the clerk of the State Corporation Commission, upon determining that a person who executed or delivered a business entity document to the clerk's office lacked the authority to act on behalf of the business entity, to refuse to accept the document for filing. The clerk is further authorized under such circumstances to summarily remove a filed document, correct the records, and notify the affected business entity.



#### PROHIBITING LOCAL GOVERNMENT FROM REQUIRING CONTRACTORS TO PROVIDE CERTAIN COMPENSATION OR BENEFITS (HB 422)

Prohibits local governing bodies from establishing provisions that would require a wage floor of any other employee benefit or compensation, above what is otherwise required by state or federal law, to be provided by a contractor to its employees as part of certain local government contracts.



#### INCOME TAXES ON DOMESTIC INTERNATIONAL SALES CORPORATIONS (HB 480/SB 575)

Exempts a domestic international sales corporation (DISC) from Virginia income taxes.



#### PERSONAL PROPERTY TAX (HB 617)

Authorizes a locality to establish lower personal property tax rates on the tangible property of businesses that locate for the first time in the locality. The lower rates would apply for the first two tax years that the business is subject to the personal property tax.

#### **BUSINESS CLIMATE & ECONOMIC DEVELOPMENT LEGISLATION**



#### ADMINISTRATION OF THE VIRGINIA JOBS INVESTMENT PROGRAM (HB 932/SB 492)

Changes the administration of the Virginia Jobs Investment Program from the Department of Small Business and Supplier Diversity to the Virginia Economic Development Partnership Authority.



#### **ESTABLISHMENT OF A WORK-SHARE PROGRAM** (SB 110)



Creates a short-time compensation program that provides employers with the option of reducing the hours worked by employees, while permitting the employees whose hours are reduced to receive partial compensation for lost wages. Program participation requires Virginia Employment Commission approval of a plan, which must provide that the reduction in hours of work is in lieu of a layoff of an equivalent percentage of employees and that employees' health and retirement benefits cannot be reduced or eliminated under the plan. An employer is not eligible to participate in the program if it has negative unemployment experience, is assigned the maximum experience rating tax rate, is assigned the tax rate for new employers, or reduced its workforce by 20 percent or more during the preceding six months. Participating employers are required to provide information regarding whether the plan is intended to be a transition to permanent layoffs.



### INCREASE MINIMUM WAGE

(HB 32)

Increases the minimum wage from its current federally mandated level of \$7.25 per hour to \$8.50 per hour effective July 1, 2014.



#### INCREASE MINIMUM WAGE

(HB 536/SB 590)

Increases the minimum wage from its current federally mandated level of \$7.25 per hour to \$8.25 per hour effective July 1, 2014, and to \$9.25 per hour effective July 1, 2015.



#### SAFE DAYS FOR EMPLOYEES

(HB 833)

Requires private employers to allow an employee safe days, with pay, if the employee or a family member is a victim of domestic violence, sexual assault, or stalking or is a family member of a victim of domestic violence, sexual assault, or stalking. Employers are required to provide employees with 32 hours per year of safe day time if the employee has less than 120 months of employment with the employer, and 40 hours per year of safe day time if the employee has 120 or more months of employment with the employer.



Energy is the cornerstone of Virginia's economy. Having a stable, diverse, affordable energy supply supports economic development and job growth while meeting the growing needs of our population and business community.

#### **ENERGY LEGISLATION**



## VIRGINIA ENERGY PLAN

(HB 1261/SB 615)

Requires the Virginia Energy Plan (VEP) to include, with regard to any regulations proposed or promulgated by the U.S. Environmental Protection Agency (EPA) to reduce carbon dioxide emissions from fossil fuel-fired electric generating units the Clean Air Act, an analysis of the costs and benefits imposed on energy producers and electric utility customers; the effect on energy markets and reliability; and the commercial availability of technology required to comply with such regulations.



Virginia's transportation infrastructure system supports business, tourism and economic growth. With over 99 percent of the world's consumers outside of the state's borders, an effective transportation network that efficiently moves people and goods is essential to Virginia's economic prosperity.

#### STATEWIDE PRIORITIZATION PROCESS FOR TRANSPORTATION PROJECTS (HB 2)



Provides for the development of a prioritization process for projects funded by the Commonwealth Transportation Board. Such prioritization shall weight factors such as congestion mitigation, economic development, accessibility, safety, and environmental quality and be applied within each highway construction district.



#### **NEW TECHNOLOGIES AND INNOVATIONS IN STATEWIDE** TRANSPORTATION PROGRAMS (HB 1090)



Requires the Secretary of Transportation and VDOT to incorporate new smart road technologies and innovations in statewide transportation technology programs.



#### INNOVATION AND TECHNOLOGY TRANSPORTATION FUND (HB 1095)



It directs 5 percent of the Commonwealth Transportation Board formula funds to a newly created Innovation and Technology Transportation Fund for high-tech infrastructure improvements that reduce congestion, improve mobility, improve safety, provide up-to-date travel data, or improve emergency response.





To be successful in the global economy, Virginia must support key technology sectors, encourage innovation and boost entrepreneurship. It is important that Virginia focus on making the Commonwealth the top place in the world in which to start and grow a business.

Virginia has the highest concentration of technology workers in the country and ranks 4th in total technology employment as reported in Cyberstates 2013.

According to the US Small Business Administration, startup businesses accounted for about 40 percent of the private sector's net new jobs over the past two decades.

#### TECHNOLOGY, INNOVATION & STARTUPS



#### PARTICIPATION BY STATE CORPORATION COMMISSION IN THE VIRGINIA BUSINESS ONE STOP ELECTRONIC **PORTAL PROGRAM**



(HB 167)

Requires the State Corporation Commission (SCC) to connect the SCC's eFile system to the Business Permitting Center by December 1, 2014.



#### UNEMPLOYMENT COMPENSATION BENEFIT RATIO (HB 22)

Removes state unemployment tax rate penalty that detrimentally impacts small businesses.



#### ENTREPRENEUR-IN-RESIDENCE PROGRAM (HB 321/SB 362)

Creates the Entrepreneur-in-Residence Program to improve outreach by state government to the private sector. The objectives of the Program are to (i) strengthen coordination and interaction between state government and the private sector on issues relevant to entrepreneurs and small business concerns and (ii) make state government programs and operations simpler, easier to access, more efficient, and more responsive to the needs of small business concerns and entrepreneurs.



#### PATENT INFRINGEMENT ASSERTIONS MADE IN BAD FAITH (HB 375/SB 150)

Prohibits any person from making in bad faith an assertion of patent infringement. The Attorney General or an attorney for the Commonwealth is empowered to accept assurances of voluntary compliance and seek injunctive relief. The Attorney General is authorized to issue civil investigative demands.



#### RESEARCH AND DEVELOPMENT EXPENSES TAX CREDIT (HB 1220/SB 623)



Increases the annual cap for the Research and Development Expenses Tax Credit from \$5 million to \$6 million. This bill would also increase the amount of Research and Development Expenses Tax Credits that each taxpayer could claim to an amount equal to 15 percent of the first \$234,000 in Virginia qualified research and development expenses paid or incurred by the taxpayer or 20 percent of the first \$234,000 in such expenses if the Virginia qualified research was conducted in conjunction with a Virginia public or private college or university.

# GRADING CRITERIA

- Legislators were docked 6 points for voting against the Virginia Chamber's position on a bill.
- Legislators were docked 4 points for carrying or co-sponsoring a bill that the Virginia Chamber opposed.
- Legislators were docked 2 points for not voting on a bill. If a leave of absence was granted on the day of the vote, points were not docked.

Since legislators refrain from voting in cases of an ethical conflict, if a legislator ABSTAINED from a vote, this was not counted against them.
