

**Overview of

COVID19 Posture: UPDATE #3  
(17April to 08 May 2020)**

**Office of Secretary of Veterans & Defense Affairs:**

- Maintained key support and leadership role in Virginia Emergency Operations Center;
- Coordinated the Governor's request for an extension of Title-32 orders for Va. National Guard;
- Engaged the commanders of DoD installations in Virginia and the Directors of the VA Medical Centers to discuss capabilities to support Virginia's lab capacity and testing efforts;
- Conducted virtual "town halls" for more than 400 Virginia Department of Veterans Services employees to discuss impacts of the COVID-19 pandemic on agency operations and commend employees for how they have adapted to continue delivering quality services to veterans;
- Organized discussion with Virginia National Guard, Virginia Department of Health and Governor's health diversity and equity team to discuss outreach to traditionally underserved populations;
- Provided outreach and updates to Bristol and Norton virtual community forums on veterans' services;
- Engaged with Association of Defense Communities (ADC) to attend webinars focused on how military families are coping with economic and psychological impacts of the pandemic.
- Coordinated Military Spouse day recognition May 8, 2020. The Secretary's bills (HB967 and SB981) to enhance Virginia's existing expedited spousal licensure process were signed into law by Governor Northam.

**Virginia Department of Military Affairs:**

- Deployed CBRNE Enhanced Response Force Package (CERF-P) teams across the Commonwealth to support expanded COVID testing and point prevalence operations, PPE and decontamination coaching:
  - 4,312 point prevalence testing samples conducted across 14 locations;
  - 2,185 sample test kits delivered to state and local partners;
  - 970 test samples transported to various lab locations;
  - 426 N95/PPE fittings;
  - 75 personnel coached on infection control strategies;
  - 118 first responder decontaminations.
- Mobilized more than 500 Guardsmen to Title 32 status;
- Continued planning and preparation with Virginia Department of Health (VDH) to coordinate support to the Governor's Long Term Care Facility Task Force;
- Fulfilling mission assignments requested through emergency management process, to include logistics support, planning, mobile testing assistance and medical planning.

- Participated in Va. Chamber of Commerce Foundation's Military & Veterans Affairs Council meeting to discuss strategies to attract Veterans and Transitioning Service Members to jobs in the Commonwealth;
- Governor Northam joined Secretariat, Agency, and the staff of Virginia's two Veteran Care Centers for a call to thank them for the hard work the staff have taken to address COVID-19 and care for veterans;
- Participated in the U.S. Department of Veterans Affairs – Office of Inter-Governmental Affairs' COVID-19 Briefing Call concerning National Cemetery Administration's updated protocols.

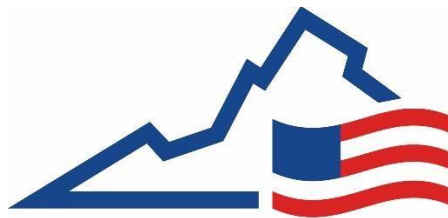
